### POSITION OBJECTIVE

The Associate Nurse Unit Manager (ANUM) is responsible for the delivery of high-quality person-centred care in conjunction with the Unit Manager during business hours. The ANUM will have the skill and ability to monitor the provision of clinical care that is consistent with the organisational policies and procedures to ensure high standards of contemporary care are delivered. The ANUM is responsible for the overall unit management in the absence of the NUM during business hours including the Urgent Care Centre.

At ORH ANUMs are also required to act in the position of After Hours Hospital Coordinator as per the roster to fill periods of unplanned leave. Therefore, in accepting this position the incumbent must be prepared to accept the responsibilities and be familiar with the requirements of those positions.

- Provides support, training, mentoring and supervision to students, graduate nurses and all other nursing staff and direct care providers e.g. Personal Care Assistants.
- Practices within the policies and procedures of Orbost Regional Health.
- Is competent at care planning and is able to identify individual health needs, determine expected health outcomes and time frames for achieving these in collaboration with other health professionals.
- Encourages active participation of patients and residents in planning and provision of their health care.
- Is competent at determining clinical deterioration and reporting this in a timely manner to the NUM and virtual model of care.
- Supports patients/residents to make choices within the boundaries of safety and acknowledges the rights of individuals and groups.
- Has the ability to manage emergency situations including competence in cardiac monitoring and Automated External Defibrillation
- Respects the values, customs, spiritual beliefs and practices of all patients and residents and their significant others.
- The ANUM liaises with appropriate professionals and clinical staff as required and in particular the NUM or Director Clinical and Aged Care Services when nursing care requires expertise beyond their scope.
